Right of Transference of Patent Rights.-- Patents or any interest therein may be assigned by an instrument in writing, and the patentee, his assigns or legal representatives, may in like manner grant and convey an exclusive right under the patent;<sup>18</sup> and where the conveyance precedes the granting of the patent, it may be issued to the assignee, the assignment thereof being first entered of record in the Patent Office.<sup>19</sup> Not only is a patentee privileged to assign it in toto, but he may grant limited rights of manufacture and sale to others.<sup>20</sup> In the language of Mr. Justice Peckham, "an owner of a patent has the right to sell it or to keep it; to manufacture the article himself or license others to manufacture it; to sell such article himself or to authorize others to sell it." 1 An assignment of rights secured by letters patent is a contract, and like other contracts it is to be construed so as to carry out the intentions of the parties thereto. During the term for which the patent is granted the assignee of all the right, title, and interest of the patentee in the same may himself sell, assign, and convey the patent for the residue of the term granted, or he may...
